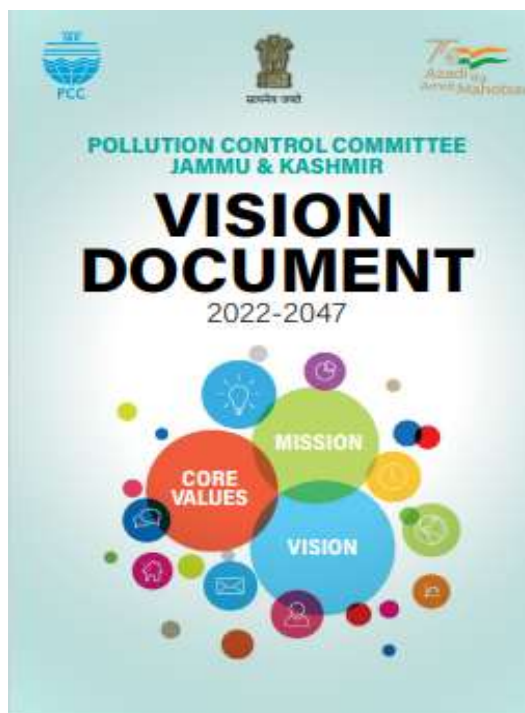

CORE VALUES

- » **PRINCIPLED AND ETHICAL APPROACH:** The JKPC shall ensure that all its decisions and actions are built on the principles of honesty, environmental ethics and respect for human rights.
- » **RATIONALITY AND CONSISTENCY:** The JKPC shall ensure rationality and consistency in decision making through decisions based on rigorous scientific analysis of monitored data as well as standardizing decision making procedures.
- » **EFFICIENCY:** The JKPC shall streamline all procedures and protocols to minimize delays in decisions and actions.
- » **TRANSPARENCY:** The JKPC shall ensure transparency of its regulatory mechanisms, including monitoring and enforcement by placing monitored data, regulations, notifications, decisions, and actions in the public domain through its website, publications, mass media, social media and other means.
- » **TEAMWORK AND PARTNERSHIP:** The JKPC shall actively foster its partnerships with all stakeholders including industries, civic bodies, government departments and the community through sharing knowledge and technical expertise and will enable their co-operation in its regulatory mechanism.
- » **ACCESSIBILITY:** The JKPC shall ensure that its regulatory mechanism is made more accessible by introducing clarity in compliance and other procedures, spreading public awareness and effectively and promptly responding to public grievances.
- » **PREDICTION AND PREVENTION:** The JKPC shall adopt a predictive and preventive approach to pollution control and environmental management by anticipating future environmental hazards and challenges and developing and implementing pre-emptive strategies to address them.

Developing the regulatory framework and creating strategic programmes for mitigating and preventing current and future environmental challenges.

Enhance the compliance management system through innovations in compliance monitoring and enforcement.

Ensuring stakeholder participation and satisfaction in the regulatory process through innovations in the consent management system.
