Pursuance to the approval accorded by the Board in its 32nd Board Meeting, the fee structure for **Health Care Facilities** for grant of authorization by the Board under **Bio Medical Waste Management Rules 2016** (bedded / non bedded) w.e.f. 1st January, 2019 is prescribed as under:



***Period of Authorization:-**

- Authorization for bedded HCFs shall be synchronized with the validity of the consents and the consent fees shall be as per the "capital investment", as per Order 59 SPCB of 2016 dt. 29/03/2016.
- The hospitals (bedded) having total waste-water generation more than 100 KLD (as per the revised classification of industrial sectors published by CPCB) and hospitals with incinerator, irrespective of the quantity of the waste water generation, will be categorized as **RED category**.
- The hospitals (bedded) having total waste-water generation less than 100 KLD will be categorized as **Orange Category**.
- The Authorization of health care facilities (bedded-less than 30 beds), being processed by the respective Regional Directors (as per the 28th Board Meeting, dt. 3/2/2016) shall be **synchronized with the validity of consent**. For non-bedded occupiers, only authorization has to be sought. It is hereby further ordered that the initial period of validity, in case of non-bedded HCFs shall be **Twelve years**.
