Whereas, no activity having bearing on environment can be taken in hand without prior consent of the Pollution Control Committee as warranted under Section 25/26 of the Water (Prevention and Control of Pollution) Act 1974 and Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 respectively; and

Whereas, Automobile Workshop is categorized as Orange Category activity on the basis of pollution potential, for the purpose of seeking the consent from the J&K Pollution Control Committee; and

Whereas, M/s Nazir Automobiles, near Petrol Pump, Natipora, Srinagar, has been set up and put into operation without obtaining consent from the J&K Pollution Control Committee in flagrant violation of the Water (Prevention and Control of Pollution) Act 1974 and the Air (Prevention and Control of Pollution) Act, 1981 and operation of the unit with present status can prove detrimental to human health and environment; and

Whereas, the unit holder was accordingly served with repeated notices, particularly notice dated 11-07-2024, calling upon him there under to show reasons as to why legal action including closure of his unit be not taken; and

Whereas, the unit holder despite repeated notices failed to show any tenable response to the notices issued to him, besides, failing to take measures to meet the requirements of laws governing environmental protection; and

Whereas, the Regional Director, PCC Kashmir while confirming the report of Divisional Officer, PCC Srinagar has recommended closure of the unit vide his No. PCC/ROK/LS/24/Clo/70-71 dated 02-08-2024; and

Whereas, the above said unit cannot be allowed to operate with above status as the operation can prove detrimental for human health and environment besides, being in flagrant violation of laws governing environmental protection.

Now, therefore, in view of the above and in exercise of the powers vested with J & K Pollution Control Committee under Section 33 (A) of Water (Prevention and Control of Pollution) Act, 1974 and Section 31 (A) of the Air (Prevention and Control of Pollution) Act, 1981, the following directions are hereby issued:-

- i. Deputy Commissioner/ District Magistrate, **Srinagar** is directed to close down *M/s* **Nazir Automobiles, near Petrol Pump, Natipora Srinagar** immediately.
- ii. Director, Industries and Commerce, Kashmir is directed to de-register the unit, if registered.
- iii. Executive Engineer, (KPDCL) Electric Division, AD-II, Rajbagh Srinagar is directed to disconnect the electric supply to unit immediately.
- iv. Executive Engineer, **PHE**, Srinagar is directed to disconnect the water supply to the Unit, immediately.
- v. Mr. Nazir Ahmad Tantray (Prop.) M/s Nazir Automobiles, near Petrol Pump, Natipora Srinagar is directed to cease the operation of Unit forthwith.
