**Subject: Closure of M/s Modern Furniture unit at Muniwar-District Anantnag of Mohd Shafi Dar.**

**Order No. : 231 JK PCC of 2024**  
**Dated : 31/10/2024**

Whereas, no activity having bearing on environment can be taken in hand without prior Consent of the J&K Pollution Control Committee, as warranted under Section 25/26 and Section 21 of the Water (Prevention and Control of Pollution) Act 1974 and Air (Prevention and Control of Pollution) Act, 1981 respectively; and.

Whereas, Wood Based Industrial units are classified as Green category units, on account of their pollution potential and as such consent of the Board/Committee is mandatory for establishment/operation of Wood Based Industry; and

Whereas, Mr. Mohd Shafi Dar, Proprietor of **M/s Modern Furniture unit at Muniwar-District Anantnag** has set up and put in operation a furniture manufacturing unit without mandatory consent from the J&K Pollution Control Committee and is currently in operation in violation of **Section 25/26** of the **Water** (Prevention and Control of Pollution) **Act 1974** and **Section 21** of the Air (Prevention and Control of Pollution) **Act, 1981**; and.

Whereas, pressing complaints against the operation of **M/s Modern Furniture unit at Muniwar-District Anantnag**, have been received from local residents, which stand verified on ground and found genuine; and

Whereas, Proprietor of **M/s Modern Furniture unit at Muniwar-District Anantnag**, was accordingly served with repeated notices, latest on **20-06-2024**, calling upon him to show reasons as to why legal action including closure of his joinery unit be not taken, which the unit holder failed to respond; and

Whereas, latest inspection carried out by the Divisional Officer, PCC Anantnag, reported that **M/s Modern Furniture unit at Muniwar-District Anantnag** is in operation without consent from the J&K Pollution Control Committee; and

Whereas, Regional Director, PCC Kashmir endorsed the recommendations of the Divisional Officer, PCC Anantnag and have submitted the closure format of **M/s Modern Furniture unit at Muniwar-District Anantnag**, vide letter No. PCC/ROK/LS/Clo/2024/81-82 dated 19-09-2024; and


Whereas, the operation of the furniture manufacturing unit of Mohd Sahfi Dar under the name and style of **M/s Modern Furniture unit at Muniwar-District Anantnag**, in its present status can prove detrimental for human health and environment of the area and therefore cannot be allowed to operate in the present form.

Now, therefore, in exercise of powers vested with J & K Pollution Control Committee under **Section 33 (A)** of Water (Prevention and Control of Pollution) Act, 1974 and **Section 31 (A)** of the Air (Prevention and Control of Pollution) Act, 1981, the following directions are hereby issued:-

- i. Deputy Commissioner/ District Magistrate, **Anantnag** is directed to close down the Joinery unit of Mr. Mohd Shafi Dar under the name and style **M/s Modern Furniture unit at Muniwar-District Anantnag** immediately.
- ii. Director, Industries and Commerce, **Kashmir** is directed to deregister the unit, if registered.
- iii. Executive Engineer, (KPDCL), **Anantnag** is directed to disconnect the electric supply to the above stated furniture manufacturing unit immediately.
- iv. Executive Engineer, Jal Shakti Department, **Anantnag** is directed to disconnect the water supply to the above stated furniture manufacturing unit, immediately.
- v. Mr. Mohd. Shafi Dar (Prop.) **M/s Modern Furniture unit at Muniwar-District Anantnag** is directed to cease the operation of the unit forthwith.
