**Subject: Closure of M/s Matoo Hill Stone Crusher, Village Rakshalina B.K.Pora - District Budgam.**

**Order No. : 217 JK PCC of 2024**

**Dated : 10 / 10 / 2024**

Whereas, no activity having bearing on environment can be taken in hand without prior consent of the J&K Pollution Control Committee as warranted under Section 25/26 and Section 21 of the Water (Prevention and Control of Pollution) Act 1974 and Air (Prevention and Control of Pollution) Act, 1981 respectively; and

Whereas, stone crusher is categorized as Orange Category activity on the basis of pollution potential, for the purpose of seeking the consent from the JK Pollution Control Committee; and.

Whereas, Consent to Operate (Renewal) was granted to **M/s Matoo Hill Stone Crusher, Village Rakshalina B.K.Por-District Budgam**, which was valid upto **March 2024**, with specific condition that the unit holder will submit the requisite Documents from the Revenue Department as per Rule 10 of S.O. 60 of 2021 dated 23-02-2021 within a period of three months from the issuance of CTO(R) and the unit holder has failed to obtain CTO(R) from the J&K PCC after expiry of the validity period beyond **March, 2024** and;

Whereas, Divisional Officer, PCC Budgam reported that **M/s Matoo Hill Stone Crusher, Village Rakshalina B.K.Por -District Budgam** is in operation without valid consent from the J&K Pollution Control Committee and also recommended for closure of the said stone crusher to the Regional Director, PCC Kashmir vide his No. JKPCC/DO/Budg/2024/105 dated 26-07-2024; and

Whereas, Regional Director, Pollution Control Committee Kashmir endorsed the recommendations of Divisional Officer, PCC Budgam and have also submitted closure format of **M/s Matoo Hill Stone Crusher, Village Rakshalina B.K.Por -District Budgam** vide letter No. PCC/ROK/LS/Clo/24/72-73 dated 06-08-2024; and


Whereas, **M/s Matoo Hill Stone Crusher, Village Rakshalina B.K.Por -District Budgam** is in operation in violation of **Section 25/26** of the **Water** (Prevention and Control of Pollution) **Act 1974** and **Section 21** of the **Air** (Prevention and Control of Pollution) **Act, 1981**; and

Now therefore, in view of the above and in exercise of powers vested with J & K Pollution Control Committee under Section 33 (A) of Water (Prevention and Control of Pollution) Act, 1974 and Section 31 (A) of the Air (Prevention and Control of Pollution) Act, 1981, the following directions are hereby issued:-

- i. Deputy Commissioner/ District Magistrate, Budgam is directed to close Down the stone crusher under the name and style of M/s Matoo Hill Stone Crusher, Village Rakshalina B.K.Pora -District Budgam immediately.
- ii. Director Industries and Commerce, Kashmir is directed to deregister the stone crusher, if registered.
- iii. Executive Engineer, (KPDCL) Electric Division, Budgam is directed to disconnect the electric supply to above said stone crusher immediately.
- iv. Executive Engineer, PHE, Budgam is directed to disconnect the water supply to the above said stone crusher immediately.
- v. Haji Ali Mohammad Matoo, Prop. M/s Matoo Hill Stone Crusher, Village Rakshalina B.K.Pora -District Budgam is directed to cease the operation of the stone crusher, forthwith.
