Subject: Closure of M/s Joinery unit at Uttersoo Shangus, Opposite EDI Bank-District Anantnag of Abid Hussain Nanwaie, S/o Nazir Ahmad Nanwaie R/o Uttersoo Shangus- District Anantnag.

Order No. : 232 JK PCC of 2024

Whereas, no activity having bearing on environment can be taken in hand without prior Consent of the J&K Pollution Control Committee, as warranted under Section 25/26 and Section 21 of the Water (Prevention and Control of Pollution) Act 1974 and Air (Prevention and Control of Pollution) Act, 1981 respectively; and.

Whereas, Wood Based Industrial units are classified as **Green category** units, on account of their pollution potential and as such consent of the Board/Committee is mandatory for establishment/operation of Wood Based Industry; and

Whereas, Mr. Abid Hussain Nanwaie, Proprietor of **M/s Joinery unit at Uttersoo Shangus, Opposite EDI Bank-District Anantnag**, has set up and put in operation, a Joinery Unit without mandatory consent from the J&K Pollution Control Committee and is currently in operation in violation of **Section 25/26** of the **Water** (Prevention and Control of Pollution) **Act 1974** and **Section 21** of the Air (Prevention and Control of Pollution) **Act, 1981**; and.

Whereas, pressing complaints against the operation of **M/s Joinery unit, Hiller Naibasti-Anantnag** have been received from local residents, which stand verified on ground and found genuine; and

Whereas, Proprietor of **M/s Joinery unit at Uttersoo, Shangus, Opposite EDI Bank-District Anantnag** was accordingly served with repeated notices, latest on **08-08-2024**, calling upon him to show reasons as to why legal action including closure of his joinery unit be not taken, which the unit holder failed to respond; and

Whereas, latest inspection carried out by the Divisional Officer, PCC Anantnag, reported that **M/s Joinery unit at Uttersoo, Shangus, Opposite EDI Bank-District Anantnag**, is in operation without consent from the J&K Pollution Control Committee; and

Whereas, Regional Director, PCC Kashmir endorsed the recommendations of the Divisional Officer, PCC Anantnag and have submitted the closure format of **M/s Joinery unit at Uttersoo Shangus, Opposite EDI Bank-District Anantnag**, vide letter No. PCC/ROK/LS/Clo/2024/79-80 dated 19-09-2024; and.


Whereas, the operation of the joinery unit of Abid Hussain Nanwaie under the name and style of **M/s Joinery unit at Hillar Naibasti (Arhama)-District Anantnag**, in its present status can prove detrimental for human health and environment of the area and therefore, cannot be allowed to operate in the present form.

Now, therefore, in exercise of powers vested with J & K Pollution Control Committee under **Section 33 (A)** of Water (Prevention and Control of Pollution) Act, 1974 and **Section 31 (A)** of the Air (Prevention and Control of Pollution) Act, 1981, the following directions are hereby issued:-

- i. Deputy Commissioner/ District Magistrate, **Anantnag** is directed to close down the Joinery unit of Mr. Abid Hussain Nanwaie under the name and style **Joinery unit at Utersoo Shangus, Opposite EDI Bank-District Anantnag** immediately.
- ii. Director, Industries and Commerce, **Kashmir** is directed to deregister the unit, if registered.
- iii. Executive Engineer, (KPDCL), **Anantnag** is directed to disconnect the electric supply to the above stated joinery unit immediately.
- iv. Executive Engineer, Jal Shakti Department, **Anantnag** is directed to disconnect the water supply to the above stated joinery unit, immediately.
- v. Sh Abid Hussain Nanwaie (Prop.) **M/s Joinery unit at Utersoo Shangus, Opposite EDI Bank-District Anantnag** is directed to cease the operation of the Joinery unit forthwith.
