**Subject: Closure of M/s Thakur Stone Crusher, Summerbugh Rakshalina Lasjan - District Budgam.**

**Order No. : 228 JK PCC of 2024**  
**Dated : 10 /10 /2024**

Whereas, no activity having bearing on environment can be taken in hand without prior consent of the J&K Pollution Control Committee as warranted under Section 25/26 and Section 21 of the Water (Prevention and Control of Pollution) Act 1974 and Air (Prevention and Control of Pollution) Act, 1981 respectively; and

Whereas, stone crusher is categorized as Orange Category activity on the basis of pollution potential, for the purpose of seeking the consent from the JK Pollution Control Committee; and.

Whereas, Consent to Operate (Renewal) was granted to **M/s Thakur Stone Crusher, Summerbugh Rakshalina Lasjan -District Budgam**, which was valid upto **July 2024**, with specific conditions and the unit holder has failed to obtain CTO(R) from the J&K PCC after expiry of the validity period beyond **July, 2024** and;

Whereas, Divisional Officer, PCC Budgam reported that **M/s Thakur Stone Crusher, Summerbugh Rakshalina Lasjan -District Budgam** is in operation without valid consent from the J&K Pollution Control Committee and also recommended for closure of the said stone crusher to the Regional Director, PCC Kashmir vide his No. JKPCC/DO/Budg/2024/105 dated 26-07-2024; and

Whereas, Regional Director, Pollution Control Committee Kashmir endorsed the recommendations of Divisional Officer, PCC Budgam and have also submitted closure format of **M/s Thakur Stone Crusher, Summerbugh Rakshalina Lasjan -District Budgam** vide letter No. PCC/ROK/LS/Clo/24/72-73 dated 06-08-2024; and


Whereas, **M/s Thakur Stone Crusher, Summerbugh Rakshalina Lasjan -District Budgam** is in operation in violation of **Section 25/26** of the **Water** (Prevention and Control of Pollution) Act 1974 and **Section 21** of the **Air** (Prevention and Control of Pollution) Act, 1981; and

Now therefore, in view of the above and in exercise of powers vested with J & K Pollution Control Committee under Section 33 (A) of Water (Prevention and Control of Pollution) Act, 1974 and Section 31 (A) of the Air (Prevention and Control of Pollution) Act, 1981, the following directions are hereby issued:-

- i. Deputy Commissioner/ District Magistrate, Budgam is directed to close down the stone crusher under the name and style of M/s Thakur Stone Crusher, Summerbugh Rakshalina Lasjan -District Budgam immediately.
- ii. Director Industries and Commerce, Kashmir is directed to deregister the stone crusher, if registered.
- iii. Executive Engineer, (KPDCL) Electric Division, Budgam is directed to disconnect the electric supply to above said stone crusher immediately.
- iv. Executive Engineer, PHE, Budgam is directed to disconnect the water supply to the above said stone crusher immediately.
- v. Mr. Imraj Ahmad Thakur, Prop. M/s Thakur Stone Crusher, Summerbugh Rakshalina Lasjan -District Budgam is directed to cease the operation of the stone crusher, forthwith.
